To the Indiana Economic Development Corporation,

Our southeastern Indiana businesses, organizations and institutions write this letter to collaborate with your counties, cities and towns in order to secure a share of the \$500 million in funding available through the Indiana Economic Development Corporation's Regional Economic Acceleration and Development Initiative, or READI. We believe this program could be transformative for southeastern Indiana.

The State of Indiana and IEDC's goals for this program are to accelerate economic resilience and growth, as well as make Indiana communities magnets for the talent Hoosier businesses need to thrive. Finding people of all skill levels is an ongoing challenge for a vast majority of employers, from manufacturers and restaurants to schools and tourism attractions. We urge you to make every reasonable effort to embrace the degree of regional collaboration READI requires. Based on our knowledge of the READI program, it is only with this spirit of regionalism that southeastern Indiana will be able to seize this once in a lifetime funding opportunity.
